## 6. **NEW BUSINESS**

- 6.01 **Discussion regarding Committee objectives and work products** Anthony Smith gave a brief presentation on the objectives and work products of CAMP. He told the members that their job was to provide feedback to staff on proposes infrastructure management strategies and priorities, assist in fostering an open dialogue with the community and staff and to brainstorm ides and solutions for infrastructure challenges. - 6.02 <u>Discussion on City Owned Infrastructure</u> Anthony Smith gave a presentation on City owned infrastructure. He discussed each type of asset the City owns:
  - Streets
  - Curbs and Gutters
  - Sidewalks
  - Pedestrian Ramps
  - Street Lights
  - Traffic Signals
  - Traffic Signs
  - Hardscape Medians
  - Backing Lots and Landscaped Medians
  - Bridges
  - Parks and Plazas
  - Trails and Walk paths
  - Buildings
  - Walls
  - Public Artwork
  - Storm Drains
  - Waterways
  - Trees

For each one, he provided the inventory number, common problems associated with the asset, the exposure to the City, Management's strategy and estimated replacement costs.

**6.03 Tour of the Maintenance Service Center** – Anthony Smith gave a brief tour of the Maintenance Service Center. The tour included stops at the Landscape

Maintenance Shop, Traffic Signal Shop, Fleet Shop and Sign Shop. At each shop he gave a brief explanation of what each area does and the various duties assigned to them.
